Cleaning	Undertake regular cleaning	<ul> <li>Clean AND disinfect frequently touched surfaces throughout the day.</li> <li>This includes tables, chairs, resources, equipment, doorknobs, light switches, countertops, handles, toilets, taps, and sinks.</li> <li>Wear one pair of disposable gloves for cleaning and dispose of immediately after cleaning.</li> <li>Using a disposable cloth, clean hard surfaces with warm soapy water, then disinfect these surfaces with the cleaning products you normally use.</li> <li>Wash hands regularly with soap and water for 20 seconds, and after removing gloves, aprons and other protection used while cleaning.</li> </ul>	<ul> <li>Risk of the virus remaining on frequently touched surfaces.</li> </ul>
	Cleaning of electronics	Regularly clean electronics, such as tablets, touch screens, keyboards, telephones and remote controls throughout the day.	<ul> <li>Risk of the virus remaining on frequently touched surfaces.</li> </ul>
	Disposal of potentially contaminated waste	<ul> <li>Waste from possible cases and cleaning of areas where possible cases have been, should be double bagged and put in a suitable secure place, marked for storage until:</li> <li>The individual tests positive or results not known; then store it for at least 72 hours and put in with the normal waste.</li> </ul>	Risk of contamination.
